Through a two-year process of sequenced interventions - including a cash transfer to start a small business, financial and life skills training, mentoring, and a savings program - REAP helps the poorest and most vulnerable women establish savings to build their resilience to shocks and lift themselves and their families out of extreme poverty. On average, 96% of women "graduate" from extreme poverty based on BOMA's strict criteria, meaning they have food for their children, diversified income and savings, and the ability to pay for life-changing resources like education and medical care.
